Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

All of our venues undergo a risk assessment prior to opening, and these are reviewed annually to ensure that all operations are safe and healthy. Food halls are family venues and appeal to a wide range of demographic. We take licensing seriously and will seek to specifically engage with the areas as detailed below. All our staff go through a comprehensive staff train program (provided by CPL) to ensure that they are aware and resourced for safe operations. Within the food hall we also work with a number of independent food partners, we work alongside them to ensure that they also remain compliant in their operations.

b) The prevention of crime and disorder

CCTV will be installed on site above entrance and exit doors and outside. CCTV will be capable of recording heads and shoulders of all entering the premises. Cameras will also capture floor areas, and will provide quality colour footage linked with time and date. All recordings will be stored in a secure area/cabinet, be regularly maintained and stored on a devise that can be made available to local police when needed. Recordings will be kept for 28 days in compliance with South Yorkshire Police. Staff will be trained on this system so that when necessary we can provide immediate access. Notices will placed within the unit to inform guests of CCTV. We would also be interested in exploring further links with the Southwark Council in order to partner around anti social behaviour prevention. We are in consultation with the landlord and the local residents associate to ensure that we support all local efforts to prevent crime and disorder.

c) Public safety

Appropriate fire safety procedures have been put in place including relevant fire extinguishers, fire blankets, internally illuminated fire exit signs, smoke detectors, automotive fire suppression in cooking areas and emergency lighting. All emergency exits shall be kept free from obstruction at all times. These plans have been verified by the landlord and will link into the landlord's fire and safety procedure. We employ a health and safety consultant who works with us to produce a risk assessment and a fire risk assessment for our sites. This will be completed prior to opening and submitted to the landlord. Security is also used on all doors at busy times to ensure that customer safety is maintained.

d) The prevention of public nuisance

All customers will be asked to leave quietly. we will operate within the constraints of our lease agreement to ensure that we do not cause a nuisance to any local residents. Food halls are family orientated venues and whilst we provide food and small event activations into the evening, guest typically leave the venue by 22:30 to return home or to move on to other late-night venues. Our on-site team will monitor this, especially any outside areas. We are aware of residents living around Shad Thames and Horselydown lane. We are in direct communication with local residents group (Shad Thames Residents Association) via the landlord and have regular meetings. An operation management plan has been approved with input from residents to address their concerns around any public nuisance. At the end of an evening, security will ensure that guests leave in an orderly manner and respect the details of the operational management plan.

e) The protection of children from harm

The licensee and staff will ask persons who appear to be under the age of 25 for photographic ID such as proof of age cards, the Connexions Card and Citizen Card, photographic driving licence or passport, an official identity card issued by HM Forces or by an EU country, bearing the photograph and date of birth of bearer. All staff will be trained for underage sales prevention. The Proximity of the Pounds Park means that we will also require under 12's to always be accompanied by an adult when inside our food hall. All events hosted within our venue are family friendly and all music is likewise carefully chosen to remove any adult only lyrics or themes
